A solid foundation to build from...

- Science: IPBES Assessment
 - All parties have accepted IPBES assessment
 - The assessment provides the basis for the framework
- Existing framework (the current Strategic Plan)
- NBSAPs and reporting structure

An agenda for change

- From IPBES assessment to Vision = significant change
- Broader than 2020 framework
 - Scope
 - Influencing new sectors
 - Agriculture
 - Forestry
 - Fisheries
 - Stakeholders
 - Non state actors
 - Economic actors

New concept to integrate in Framework

- A number of new factors to consider
 - Population change: Growth and Decrease
 - Food and Agriculture
 - Human Health
 - Deforestation and restoration
- New responses
 - Whole landscape management

Resource Mobilisation

- Critical component of our workplan
 - New target to be easier to implement
- Strategy more than a framework
- Looking at
 - Non traditional sources of funding
 - Philanthropy
 - Private Sectors
 - More coherances
 - New tools
 - Risk management
 - Environmental Goods and Service ... Valuation
 - New approach: domestic budget reallocation, carbon/environmental tax
- Importance of valuation and economic studies
 - Timely availability
- GEF as the financial mechanism – role in expediting implementation of the Framework
- Exploring other new ways of mobilizing resources

Coherence

- New framework has to connect well with SDG system
 - Provide clear biodiversity content to SDG
 - Use SDG indicators where useful and appropriate
- Within Framework
 - Appropriate representation of Sustainable use, Benefit Sharing, and Biosafety
- Coordination with MEAs and other Conventions is a two way street
 - Contribution to MEAs, strengthening
 - Input from MEAs to CBD results (e.g. Chemical and pesticides)
- Simplicity , Clarity makes for good communication and transparency
- Managing Communication

Planning reporting and Review

- A way to improve communication
- Improve clarity, transparency
- Improve commitment

- Build on existing system NBSAPs etc...
- Strengthen
 - Frequency and timeliness of report
 - Comprehensive plan that are easy to communicate and integrate
